The U.S. Cotton Trust Protocol is the voluntary sustainability program for U.S. cotton growers and traceability platform for all U.S. Cotton. As the world's first cotton fiber program to offer article-level traceability, we are at the forefront of delivering full transparency and accountability throughout the cotton supply chain.

Since our inception, we have been committed to ensuring that U.S. Cotton is recognized as the most responsibly produced in the world. Our journey began with the recognition that while U.S. cotton growers were already implementing sustainable practices, there was a need for a system to measure and verify these efforts. This led to the creation of the U.S. Cotton Trust Protocol.

Today, we support our growers in their continuous improvement efforts and stand as the only cotton program that provides comprehensive field-to finished product visibility, allowing us to track cotton from the farms where it is grown to the fiber where it is turned into products.

This unique capability has positioned us as a trusted partner for brands and retailers seeking to source sustainably grown cotton.

Our commitment to continuous improvement is instrumental in shaping the future of U.S. Cotton. We regularly evaluate and refine all aspects of our operations, from farming practices to data capture and reporting methods. This commitment has allowed us to maintain our effectiveness, relevance, and alignment with the evolving needs and expectations of our stakeholders – from the fields to the shop floor to policy shapers.

In terms of our membership, we have seen significant growth. We now count a substantial portion of U.S. cotton growers among our members, along with many mills, manufacturers, and brands. 

CURRENT STATE

The Trust Protocol is the only program to offer quantifiable and measurable goals and measurement across six key sustainability metrics

GOAL

Maintain our position as an established credible framework where the field-level environmental impact of U.S. Cotton production is measured and verified, with a future where all U.S. Cotton could be sustainably certified.

STRATEGIES

Refine Measurement Methodologies

Continuously enhance quantifiable goals and metrics in line with globally (or market) relevant sustainability indicators and frameworks.

Enhance the current quantifiable and measurable goals across six key sustainability metrics.

Explore and implement new science and metrics in emerging areas such as biodiversity, regenerative, waste and the addition of social improvement indicators.

Ensure we are creating and using best in class tools that are scalable and accessible for U.S. cotton growers.

Ensure the Grower Questionnaire and Principles and Criteria are reviewed and updated on a regular basis, with a focus on capturing more significant or unique production practices.

Data Quality and Capture

Invest in technology to improve data capture and quality, ensuring accurate and reliable measurement and tracking of environmental impact at scale.

Develop a process to support growers not demonstrating improvement over time.

Develop an effective process for revisions to the Grower Questionnaire and Principles and Criteria.

Grower Recruitment and Retention

Implement strategies to recruit more growers into the program whilst retaining existing members. These should include the provision of insights to growers on the monetization of environmental and business benefit.

Demonstrate Positive Impact

Regularly publish reports demonstrating the environmental impact of the U.S. Cotton Trust Protocol, backed by verified data. Create a peer-to-peer mentoring and best practice sharing program to help drive more sustainabilityaware growers.

Partnerships and Collaborations Forge partnerships with industry players, NGOs, and government agencies as well as field partnership programs and gins to amplify impact and reach.

Brand and Value System Engagement

Continuous monitoring and alignment towards globally benchmarked measurements and frameworks as well as compliance and regulatory requirements.

CURRENT STATE

The Trust Protocol is the first cotton fiber program to offer article level traceability.

GOAL

Deliver a comprehensive, scaled, traceability system that is accessible and enables full transparency and accountability throughout the cotton supply chain.

STRATEGIES

Scaling Up

Design and deliver a formalized playbook, tools and training which enable the adoption and scaling of the program across the supply chain.

Design and deliver accessible sourcing solution value proposition that allows members (brands and retailers and mills and manufacturers) to easily visualize and find members, active mills and manufacturers and eventually inventories of Trust Protocol eligible materials through the ecosystem.

Enhance our Infrastructure

Explore additional technology partners to enhance articlelevel traceability as well as interoperability as well as create the human resource infrastructure necessary to deliver effective support to participants involved in scaling the PCMS across the full supply chain.

Engage Stakeholders with Training and Education

Conduct workshops and training sessions for all stakeholders to ensure they understand how to use and benefit from the traceability system and help design its continued evolution.

Develop self-supporting tools for members once they have onboarded.


Assurance


Create value for downstream users of cotton: provide traceability platform that reduces brand risks and creates opportunities to communicate aspects of sustainability.



GOAL

STRATEGIES

Process Improvement

Regularly evaluate and refine our practices, data capture methods, and reporting protocols to ensure we deliver on our commitment to continuous improvement and thereby regularly updating the U.S. Cotton Trust Protocol based on stakeholder feedback, new research findings, and changes in the industry and regulatory landscape.

Capacity Building

Accelerate grower uptake of sustainable practices by creating a Field Innovation Fund which can be used to identify new practices, help save money, stimulate uptake and improve efficiencies.

Maximize the opportunities provided by the Climate Smart Cotton Program grant to support growers with financial and operational incentives to drive broader sustainable cotton production uptake across the U.S.

Conduct training programs for growers, manufacturers, retailers, and other stakeholders to ensure they have the skills and knowledge needed to support sustainable cotton production.

Conduct training for mills, manufacturers, brands and general public so that they better understand how the cotton in their items is grown.

Strengthen and Simplify the Program

Develop a roadmap to streamline processes, making them more efficient and user-friendly. Evolve the value proposition based on industry trends and customer feedback to ensure it remains compelling and relevant.

Pursue Partnerships with Shared Purpose and Vision


Identify and engage potential partners who share the U.S. Cotton Trust Protocol's commitment to sustainability and traceability. This could include other industry players, NGOs, government agencies, or research institutions. Develop joint initiatives that leverage each partner's strengths and resources to amplify impact.

Explore Forward-Looking Models and Markets

Conduct research to identify emerging trends and opportunities in the market, such as carbon trading or circular economy models. Develop pilot projects or partnerships to test these new approaches and assess their potential benefits for the U.S. Cotton Trust Protocol. Aim to be the organization who has the next move ready to assist growers in their sustainability efforts and their financial opportunity and is seen as the leading sustainability resource for all U.S. cotton growers.

Implement rigorous verification processes to help ensure that all participants in the U.S. Cotton Trust Protocol's supply chain are acting ethically and responsibly. This could include background checks, audits, or third-party certifications.

CONTINUOUS IMPROVEMENT

These 3 pillars are underpinned by our unwavering commitment to **integrity**.

Governance

Ensure a robust governance structure that ensures accountability, transparency, and effective decision-making within the U.S. Cotton Trust Protocol. This could include setting up committees or working groups, defining roles and responsibilities, and implementing policies and procedures for key processes.

Funding

Develop a sustainable funding model to support the ongoing operations and growth of the U.S. Cotton Trust Protocol. This could involve seeking grants, sponsorships, or partnerships, as well as directly exploring revenue-generating activities of membership and consumption fees.

Regular Review of Member and Stakeholder Frameworks

Conduct regular reviews of core program documents including Claims Framework, Principles and Criteria, and Theory of Change to ensure they remain accurate, relevant, and compliant with industry standards and regulations. Update the framework as needed based on these reviews.

Stakeholder Alignment

Foster strong relationships with stakeholders through regular engagement, feedback sessions and collaborative initiatives. Use insights gained from these interactions to continuously improve the U.S. Cotton Trust Protocol and align it with stakeholders' evolving needs and expectations.

Communication and Marketing

Develop and implement a comprehensive communication and marketing strategy to promote the U.S. Cotton Trust Protocol and its benefits to key stakeholders. This could include public relations campaigns, social media engagement, content marketing, events, and other tactics to raise awareness and build the U.S. Cotton Trust Protocol's reputation as a leader in sustainable and traceable cotton production.

Risk Mitigation and Management


Progress Policy Agenda and Industry Landscape
